

Attorney Jan Nielsen Little concisely brings to light how a woman's unique traits make for a great trial attorney in her article "Ten Reasons Why Women Make Great Trial Lawyers." Little's article also touches on some of the perceptions associated with women lawyers. For instance, trial lawyers are thought to be strong, both physically and emotionally. A woman's ability to be flexible demonstrates resilience and strength, both of which are crucial to handling a trial without breaking in the middle of it. Women are resourceful and willing to employ a wide range of tools to deal with unexpected situations. Studies also identify women as often being the sex best equipped to read and empathize with people. Women prefer collaboration to coercion, which is critical in this day and age given that women make up half of your audience, including not only your jurors, but your federal and state judges and courtroom employees, as well. Even though women do not necessarily enjoy competition per se, most women do like to win. Women have a knack for keeping their eye on the end result rather than the game of trial, and have the ability to maintain focus on the substance of what is happening.

Looking this year at my 40th birthday, 20 years consumed in some capacity with litigation and trials, and now the biggest blessing of the birth of my first child, I still am intrigued at the discussions regarding women trial lawyers. We each have our own stories to tell, and as always, the story you hear is often contingent upon the audience. Regardless of the story or audience, I am certain few of us, despite popular belief, would tell the story of a life like that of the ladies on "Sex in the City" — kicked back nightly while sipping on martinis. One of my male partners recently expressed concern that, "Female trial lawyers are a dying breed." My thought, "Female trial lawyers certainly aren't dying, nor are we taking it easy," but rather, we are becoming

more confident to make choices which are better suited for our individual lives both in and out of the courtroom. Women and the legal profession, generally, seem to be embracing the novelty of the female trial attorney and recognize that any differences that exist compared to our male partners are, and can, be quite beneficial.


